As background for our discussion I have sent Emma a copy of the questions we discussed last November with Councillor Brian Grocock and the written response we then received.

3. Minutes of the Pedals Meeting Held 17th July 2006 at the Globe.

Present: Hugh McClintock, Susan Young, Peter Osborne, Chris Gardner, David Miller, Lawrence Geary, John Bannister, Arthur Williams & John Park.

Apologies for absence: Bill Istead, Andrew Martin, Mara Ozolins, John Wilson, Roy Wilson and Jamie Fletcher.

Trailer. Peter Osborne and Chris Gardner to retrieve and sort out contents of the trailer over the summer.

Asda at Hyson Green: A cycle event was held here on July 12th. The Ridewise stall was manned by Susan and Hugh. John and Pippa Hand did a Dr. Bike.

City Maps. A profitable meeting was held on July 4th about updating these maps.

East Midlands Cycling Groups Meeting. Pedals is hosting the next meeting at the Globe on November 11th. Details will be finalised over the next few months. It is envisaged that there will be short informal presentations and discussions. A buffet will be provided at a modest cost.

Finance. Another cheque for £1000 has been received from Nelsons for the next three issues.

David Miller has received a cheque for £300 in connection with the Jack Taylor cycle shop that closed in West Bridgford about five years ago. Most standing orders are in now. Sue requires another cosignature for issuing cheques.

Autumn and Winter Meetings. In accordance with Pedals' efforts to cultivate local politicians, Emma Dewinton will give a short presentation at September's meeting.

Midland Mainline Cycle Policy. Hugh to make a response to this by August 6th.

Canal Towpath. There are ongoing problems with drunks and overgrown vegetation.

Carrington Street. Major changes are due for this in 2007.

Bollards on Queen's Bridge Road. These are going to be fixed.

Beeston High Road East Contraflow Cycle Lane. Generally this is OK. There is some parking in the cycle lane. Construction work is still to finish.

Update:

Bike trailer - message from Chris Gardner to Peter Osborne (25 August)

"Pete

You may remember that I mentioned my Uncle might be interested in the trailer and now that he has had chance to have a look at it whilst on his postal rides he would like to make Pedals an offer of £50. He also said that now he has started cycling again he may be willing to lend it back to Pedals on the few occasions a year if needed, although he said it might be a different colour and reinforced to carry something heavier; he obviously has some plans :-)

Let me know if this is an option that Pedals would consider. cheers, Chris"

East Midlands new rail franchise and cycling

After further consultation with Dave Holladay, CTC Public Transport Campaigner, I decided that it was best to leave the detailed response to him.

City cycle maps revision

Having strongly recommended to Steve Brewer and Ged Newton that they contact Roger Codling to tap his unrivalled detailed knowledge of (the north side of) Nottingham to help ensure that the new cycle maps are error free I have recently gathered from Roger that they have still not been in touch with him! However, Steve has now told me that they will be in touch with Roger shortly.

Fairham Brook cycle path (Silverdale-Clifton)

I had a useful meeting with John Lee about this and the problems that the new barriers have caused. I have pointed him in the direction in the useful advice about barriers from Sustrans.

Cyclist access to Wollaton Park - copy of message of 8 August from Angela Gilbert: "Dear Hugh,

I sincerely hope you are enjoying your "retirement" and getting plenty of cycle miles under your belt.

You may recall that I had communication with the City Council about cycle access to Wollaton Park at the main entrance on Wollaton Road, airing my concerns about the cattle grids and parallel humps.

Bob Chaffin's reply is attached and whilst I appreciate the point he is putting forward, overall I find his reply rather unsatisfactory. Not only is "use the pedestrian gate" not a safe option for cyclists or adjacent pedestrians, access to the pedestrian gates is not straightforward from the road and will invariably entail cycling on the footpath. In fact on exit that involves cycling over the car park, bumping up the kerb and cycling the length of the road on the footpath.

I understand his concerns about escaping deer but surely deer would not carefully pick their way over a 12" cycle track if one were put down alongside the cattle grid.

I welcome the suggestion of moving the humps away from the grid but really I can't see the point of the humps at all. At the moment traffic slows over the humps in first gear but then accelerates away, hardly the desired effect from a safety point of view. I also see children on bicycles playing over the humps and grid, over and over, which they seem to think is great fun.

Hugh, I wonder if Pedals could take this up on my behalf please or offer advice how I can take this further? I feel I am one lone voice yet there are many many cyclists who use Wollaton Park for their daily commute

...Letter from Bob Chaffin, City Council, 7 August "Dear Mrs Gilbert WOLLATON PARK

May I apologise for the oversight in not responding earlier to your concerns regarding the cattle grids at Wollaton Park.

As you will appreciate the City Council has a duty to ensure that the Deer do not escape from the park as they pose a danger to traffic and to health and safety, hence the introduction of cattle grids at the entrance and exit gates on Wollaton Road. As you will be aware, cattle grids are an established means of preventing escape in Parks and rural areas.

Unfortunately, it is not possible to move the fencing back as the Deer can then escape. Earlier this year on three occasions when pedestrians have moved the barriers back deer have escaped from the Park and therefore the fencing has now been secured in position whilst we await permanent fencing. Likewise it is not possible to provide a path around the grids as this will also provide an escape route for the Deer

With regard to the speed humps these are necessary to slow the traffic down to traverse the grids at the correct speed. We will however be moving the humps slightly away from the grids to allow for momentum to be maintained.

I understand your concerns however, as you will be aware, with the exception of the vehicle entrances all other gates are used by both pedestrians and cyclists and this has been the case for many years and I am not aware of any difficulties being encountered.

With regard to the main vehicle entrances, new signs will be installed shortly advising cyclists to dismount

and use the pedestrian gates. Whilst this may be slightly inconvenient, it will I feel provide a practical option to the situation and will enable cyclists to access the park but also ensure that the Deer cannot escape.

"With regards to the website, I've tried a few times to contact Dave Silvester who had offered us some help. However, I've not had any response (which didn't seem like him). I had a quick look at his own private and business websites and those don't seem to have been updated for quite a while, so I'm wondering if he's done something like go travelling.

Consequently, I've had a hunt over the internet for website development software. The software I've currently got is really aimed at professional developers which makes it a bit harder to use.

So I've just ordered some software which is supposed to include template and example websites which you can customise and build upon. It's aimed much more at the non-professional developer, which should be fine for me to work from. I'm going to have a look at this and see what it allows me to produce.

With regards to the offer of advice if needed from Alan Odell, that is much appreciated. However, from the point of view of the code itself for a simple website, I don't think that's such an issue for me. I've a basic understanding of HTML.

The problem for me was/is one of graphic design to get the site looking good. Dave has these skills as well as the developer skills, which was why I jumped at his original offer. Once designed, images produced and easier structure to maintain than we've currently got, I would have been happy with that.

Anyway, once I've got this software over the next couple of weeks (it's being sent to my Nottingham address), I'll have a play with it and see what I can produce from the templates/examples. regards, Alistair"

5. East Midlands Regional Cycling Groups meeting, Saturday 11 November

We need to finalise the programme so that we can email out details and start to encourage people to register.

In July we discussed the idea of a programme with 3 speakers, i.e. myself doing a bit of background about Pedals and our current concerns, an update from Bella Stewart of Derby City Council on the Cycle

Derby Project, and someone from Midland Main Line on bike and rail issues.

Since then I have had further thoughts and exchanges of emails with John Stubbs, Chair of the Derby Cycling Group and Convenor of the East Midlands Cycling Forum and am now inclined, if people agree, to drop the third speaker idea. The reasons for this are a) because it is now only just over a year until MML's franchise runs out and is replaced by the new franchise for railways in the East Midlands (new franchise holder not yet known, of course) and because the key body to influence in terms of bikes on rail policy is now DfT Rail, i.e. it is really a national issue that, I suggest, is best left to the national CTC/CCN cycle campaigners' conference.

I therefore suggest that we have just the two speaker slots (of 20-25 minutes each, plus 10-15 minutes for discussion), followed by an hour or so for lunch (where informal discussion can continue). After lunch we can have general forum discussion for 45-60 minutes, followed by, for those who want, a guided ride for 1-2 hours, timed to finish just before it gets dark (c 5 p.m. at that time of year). Those who don't want to stay for the ride can then leave for the station or wherever directly after lunch, i.e. the order of the ride and the final discussion would be reversed from the way the initial event in Derby in May was organised

Exact timing will also need to take account of

- a) the times of the main trains arriving in Nottingham between 10-11 from Leicester, Derby, Lincoln etc. and allowing time to guide people from the station to the pub and secure their bikes
- b) what allowance we want to make for the fact that this day is Remembrance Day and the national two minute silence at 11.00
- c) Just how long The Glob PH think they will need to layout and serve lunch, which will have to be in the same room as our meeting. We should be able to reduce the time for this if people have signified their preference for the menu in advance and paid up when the register.

What do people think about this suggested timing? I would now like to finalise the programme.

Allowing space for catering I am inclined to suggest that we limit numbers to 50, if people agree.*

Carlton Street-Victoria Street (Hockley) (copy of message of 14 August from Chris Dixon to Steve Brewer)

"Steve,

I hope you can reassure me that cyclists are not being ignored again by NCC Highways in the current works in Hockley.

The route into town up Goosegate > Carlton Street > Victoria Street is a designated cycle route which was blighted last year by the un-joined-up thinking of NCC Highways who introduced a one-way restriction to the short section between George Street and Victoria Street, without marking a contraflow lane for cycles. Cyclists have of course continued to use this route into town despite being cut-up daily by oncoming bus drivers who now assume they have the whole road.

I see from the contractor's markings on the road that the carriageway is now about to be reduced in width, again without any apparent thought for cyclists for whom it will be impossible to navigate this short section alongside an oncoming bus swinging round to get into George Street. This is despite any apparent logic - the pavement outside Sonny's restaurant is already massive and is being extended further.

I know that Pedals have spoken to NCC on many occasions to try and remedy this foul-up and it's about time it was sorted out. The route appears on the city's maps as a cycle route after all! Regards, Chris Dixon" mr.chrisdixon@googlemail.com

PS. Having now had a chance to visit the site again in the light of Chris' message I think it is premature to raise further concerns about this scheme construction of which is still at a very early stage. We made our concerns about the original proposals quite clear earlier in the year and the City Council did agree to various changes in the light of them.

A453 widening proposals: message from Colin Shields, White Young Green, Leicester "Dear Sir/Madam,

As you may be aware White Young Green is working as Designer on the A453 widening scheme for Laing

O'Rourke Civil Engineering Ltd. The Highway Agency have appointed Laing O'Rourke as the contractor for the scheme.

We are currently reviewing the scheme in respect of pedestrian, cyclist and equestrian (Non-Motorised User) facilities, and propose to hold a focus group the week commencing Monday 2nd October to discuss issues relating to Non-Motorised Users. PS The meeting is now due to be held on 2 October, I understand. Our recent pressure on the need for good standard provision seems to be starting to bear some fruit.

Improving cycle route signing in The Meadows – copy of my message of 8 September to Cathy Melia, Graham Lansdell and Dave Clark: "Dear all.

This morning I had a meeting with Kerry Haley from the City Council who has been asked by Steve Brewer to help him in producing a detailed list of improvements to cycle route signing in The Meadows.

Since so many such signs in The Meadows have gone missing over the years, or at least have been vandalised and loosened, and have not been repaired or replaced, I know that there are many defects. I pointed out to her examples of many locations where signs have gone missing and been reported, often several times but still no action has been taken. I therefore emphasised the need both for these locations to be sorted out and for much more attention in future to making signs vandal-resistant and more secure.

To help Kerry with this task I agreed that I would raise the matter at the next Pedals meeting, on Monday week, and ask people to let me have detailed comments and suggestions. To help get this process underway I thought I would send this message now to you all, in view of your detailed local knowledge.

Please therefore let me have your suggestions as soon as convenient, Hugh"

Bader Road, Wilford cycle link proposal to Gresham Park – message of 28 July from Jonathan Shewell-Cooper "Hugh,

I have at last tracked down a copy of the plans for the cycle and footpaths for the Gresham Park development - thanks to Susan Harley at Rushcliffe development.

They may be subject to change - M. Green at Notts Council is looking at that. Plus there are still some reserved matters to be looked at.

However the key bit is that the North South cycle

path will run parallel to the railway line past were my suggests path from Bader road would intersect it. This means there would be no (minimal) work on the county side of the boundary - we would just have to persuade the city council.

However, we were amazed that the National Water Sports Centre had no cycle racks and we ended up locking my wife's bike to a convenient lamp post - not the sort of facility we expected at all!

I wonder if your organisation could ask the Centre to consider putting some cycle facilities near the main centre.

Improving cycle facilities – Weir Field, Beeston (copy of message of 17 August from Robin Phillips):

"Dear Hugh, Steve, and South Notts Highways, Please pass this suggestion on if you are not the appropriate person to handle it.

One the Weir Fields recreation ground, Beeston, close to Beeston Lock on the Beeston Canal, there have recently been some (welcome) repairs of the path surface, which leads from the Meadow Lane Bridge to the Lock on the SOUTH side of the canal.

I noticed also that an outdoor picnic table has recently been placed on the grassy area nearby.

I would like to suggest, as this is a popular area used by young people, walkers, and ramblers, that it would be good to install a couple of Sheffield stands so that bikes could be left safely which the owner is involved in games. Best wishes, Robin."

Bridge over Beeston canal (copy of message of 17 August from Robin Phillips):

"Dear Hugh and Steve,

If this is better handled by someone else please feel free to pass it on!

At the bottom end of meadow Road Beeston, where it meets the Beeston Canal, there is a hump-backed bridge paved with largish granite setts, and beyond it one can turn either left (towards Nottingham along the towpath) or right (towards Beeston Lock and the Marina.

I would like to suggest two things:

1) The setts on the bridge are so large and the hump so high

that going over the bridge is much more or a problem for

cyclists than it would be if the setts were smaller and less

bumpy.

2) It is very difficult. if you go over the bridge and try

to turn right, to avoid falling off, as the footpath going

west could do with a sharp camber to take the right turn

safely.

Road repairs on Queen's Road, Beeston (copy of message of 17 August from Robin Phillips): "Dear Hugh and Ian.

I imagine you share my disappointment at the very poor state of the road surface on Queen's Road, Beeston, which had a complete re-surfacing only 2 or 3 years ago.

1) On the "south" or east side of the westbound carriageway, after you pass the Beacon Road turnoff but just before you come to Humber Road, there is an area of very rough surface, where it appears a repair has been unfinished. Clearly the wire scouring machines which are run over the surface before major laying of tarmac have been used, but the surface has not been made good. The area is about 2 or 3 metres long and probably not more than 1 metre wide, but along with rainwater gulley covers it is no help to the cyclist, and should never have been left in this state.

2) All along the Queens Road on the westbound carriageway, mostly between Tattershall Drive and Station Road, I am conscious that at regular intervals the tarmac is cracked right across to the centre of the road, presumably at the end of each underlying concrete slab. I

suppose tar-banding at these points would help to prevent further deterioration in the winter frosts, but I am really surprised at the number of cracks and holes that are developing. I wonder, does the Transportation section monitor the performance of resurfaced roads,

with a view to selecting the most reliable contractors in the future?

3) You gather that I have noticed a fair number of

faults in this area, and I could enumerate them if you feel it would be helpful.

If Ian is not the right person to handle complaints for this area, perhaps he would be kind enough to pass it to the appropriate person? Many thanks, Robin."
